Please read this packet over carefully as it contains important information concerning your enrollment in the Cosmetology Program.

- 1. All students enrolling in the Cosmetology Course in the State of Pennsylvania must complete an application and have the application notarized. The application is enclosed. PLEASE HAVE IT NOTARIZED AND COMPLETED FOR THE FIRST DAY OF SCHOOL.
- You will need to complete 1,250 Cosmetology training hours while attending 3 years at the CTC to be able to take your state boards. PLEASE READ THE ATTENDANCE POLICY VERY CAREFULLY SO THAT YOU ARE AWARE HOW THE COURSE IS RUN.
- You will be required to purchase black LCCTC T-shirts. They are \$5 each. This will be your uniform along with black scrub pants along with COMFORTABLE athletic shoes or crocs.
- 4. Shirts purchased must be cash and exact amount. Mrs. Mangino in the front office will assist you with shirt purchases.
- 5. We will be doing fundraising and events to raise money for some expenses. You are highly encouraged to participate. Some events will be mandatory and graded.
- 6. Points listed in this memo reflect Cosmetology State Law and are followed in Cosmetology Schools across Pennsylvania. Failure to comply will result in loss of hours, disciplinary action and possible removal from the course.

Cosmetology Attendance Policy

A student enrolled in the Cosmetology course at LCCTC should be advised that guidelines are set forth by the Pennsylvania State Board of Cosmetology. The State Board has set 1,250 hours training for the completion of the course. At this time, the student will be eligible to apply for the Cosmetology exam leading to licensure. It has been concluded by the State Board that any Cosmetology student who does not successfully complete a Cosmetology course or any portion of it will not receive credit hours for the purpose of taking the Cosmetology exam (Cosmetology Law 63.P.S. 510). Therefore, if a student was to receive a failing grade for any grading period those hours would not accumulate toward the 1,250 needed.

Items you will need for Cosmetology You can easily order from amazon.

- 1. A mannequin with 100% human hair. NOT synthetic. This will be your mannequin and you will use it the entire time you are here. We will use daily. They will be colored and cut when it is time. Needed asap. Approximatley \$30.
- 2. A bag to keep your things in. A rolling suitcase or something similar. Needed asap.
- 3. A nail kit. Kit will have your own nail supplies for acrylic nails. Liquid, powder, nail glue and an acrylic nail brush. Not needed until second half of 1st year. This is ongoing. When it needs replenished it should be in a timely manner. Approximately cost \$30
- 4. A scissor kit containing scissors, thinning shears, and a razor. These come in left or right handed. Not needed until second year. Approximately cost \$20-\$50.

Names must be on your things.
